

# SIDDHARTH INSTITUTE OF ENGINEERING & TECHNOLOGY (AUTONOMOUS) Academic Regulations (R16) for M. Tech (Regular-Full time) CHOICE BASED CREDIT SYSTEM (CBCS)

(*Effective for the students admitted into I year from the Academic Year 2016-17 onwards*) **NOTE:** The regulations below are subject to amendments as may be made by the Academic Council of the College from time to time. Any or all such amendments will be effective from such date and to such batches of students (including those already undergoing the programme) as may be decided by the Academic Council. The Jawaharlal Nehru Technological University Anantapur, Ananthapuramu shall confer M.Tech. Post Graduate degree to candidates who are admitted to the Master of Technology Programs and fulfill all the requirements for the award of the degree.

# Preliminary Definitions and Nomenclature:

In the following Regulations, unless the context otherwise requires:

- (i) **"Programme"** means Degree Programme that is M.Tech Degree Programme.
- (ii) "Branch" means specialization or discipline of M.Tech Degree Programme, like Structural Engineering, Thermal Engineering etc.
- (iii) "Course" means a theory or practical subject that is normally studied in a Semester, like Software Engineering, Embedded System Concepts, Modern Control Theory etc.
- (iv) **"College/Institute"** means Siddharth Institute of Engineering & Technology, Puttur.
- (v) **"University**" means Jawaharlal Nehru Technological University Anantapur, Ananthapuramu.

#### 1. Admission Procedure:

Admissions are made to the first year of Two year M.Tech. Degree programme as per the norms of A.P. State Council of Higher Education (APSCHE), Government of Andhra Pradesh.

# 2. Programme Pattern:

- 2.1 A Candidate after securing admission must pursue the M.Tech course of study for four semester's duration.
- 2.2 Each semester shall be for a minimum of 90 instruction days including examinations.
- **2.3** A candidate admitted to a programme should complete it within a period equal
  - to twice the prescribed duration of the programme from the date of admission.

# 3. Award of M.Tech. Degree:

A student will be declared eligible for the award of the M.Tech. Degree if he/she fulfills the following academic regulations:

- 3.1 Pursues a course of study for not less than two academic years and in not more than four academic years from the year of their admission.
- 3.2 Registers for 70 credits and secure all 70 credits.
- 3.3 Students, who fail to fulfill all the academic requirements for the award of the degree within four academic years from the year of their admission, shall forfeit their seat in M.Tech. Course and their admission stands cancelled.

# 4. Courses of Study:

With the approval of AICTE & JNTUA, following courses are offered for the M.Tech. Programme from 2016-17

and any other course as approved by the authorities of statutory bodies of the college from time to time.

#### 5. Attendance:

- 5.1 A student shall be eligible to appear for final examinations if he/she acquires a minimum of 75% of attendance in aggregate of all the subjects in a semester.
- 5.2 Shortage of attendance below 65% in aggregate shall in NO case be condoned.
- 5.3 Condonation of shortage of attendance in aggregate up to 10% (65% and above and below 75%) in each semester may be granted by the College Academic Committee.
- 5.4 Students whose shortage of attendance is not condoned in any semester are not eligible to take their end semester examination of that class.
- 5.5 A student will not be promoted to the next semester unless he satisfies the attendance requirements of the present semester. They may seek re-admission for that semester when offered next.
- 5.6 A stipulated fee shall be payable towards condonation for shortage of attendance to the Institute as decided by the College Academic Committee.

#### 6. Evaluation:

The performance of the candidate in each semester shall be evaluated subject wise, with a maximum of 100 marks for theory as well as practical subjects, on the basis of internal examination and end semester examination shall be 40% and 60% respectively.

- 6.1 For theory subjects, the total internal weightage for theory courses is 40 marks with the following distribution.
  - 30 marks for Mid-term tests
  - 10 marks for Assignments

There shall be two mid-term tests in each semester. The duration of mid-term test shall be 2 hours. The test consists of 3 questions with individual choice ('either', 'or' type) for 10 marks each. First mid-term test shall be conducted for 50% of the syllabus and second mid-term for the remaining syllabus.

Between the two midterm examinations, 80% weightage will be given for the better performance and 20 % for the other. The final mid-term marks will be the addition of these two.

End semester examination for 60 marks shall consist of 5 questions (1 question from each unit) with individual choice ('either', 'or' type) for 12

marks each.

The duration of end semester examination shall be 3 hours.

- 6.2 For practical subjects, 60 marks shall be for the End Semester Examinations and 40 marks will be for internal evaluation based on the day to day performance.
- 6.3 For Seminar there will be an internal evaluation of 50 marks. A candidate has to secure a minimum of 50% to be declared successful. The assessment will be made by a board consisting of HOD and two internal experts at the end of IV semester instruction.
- 6.4 A candidate shall be deemed to have secured the minimum academic requirement in a subject if he/she secures a minimum of 40% (i.e., 24) of marks in the end examination and a minimum aggregate of 50% (i.e., 50) of the total marks in the end semester examination and internal evaluation taken together.
- 6.5 In case the candidate does not secure the minimum academic requirement in any of the subjects he/she has to reappear for the semester examination during supplementary examinations, or repeat the course when next offered or do any other specified subject as may be required.
- 6.6 10 marks allotted to assignments in each theory course shall be based on evaluation of 2 assignments (5 marks each) relevant to that particular course.

#### 7. Evaluation of Project Work:

Every candidate shall be required to submit thesis or dissertation after taking up a topic approved by the college.

- 7.1 Registration of project work: A candidate is permitted to register for the project work after satisfying the attendance requirements for all the courses (theory and practical courses of I & II Sem)
- 7.2 An Internal Departmental Committee (IDC) consisting of HOD, Supervisor and one internal senior expert shall monitor the progress of the project work.
- 7.3 The work on the project shall be initiated in the penultimate semester and continued in the final semester. The duration of the project is two semesters. The candidate can submit Project thesis with the approval of IDC after 36 weeks from the date of registration at the earliest and one calendar year from the date of registration for the project work. Extension of time within the total

permissible limit for completing the programme is to be obtained from the principal.

- 7.4 The student must submit status report at least in three different phases during the project work period. These reports must be approved by the IDC before submission of the Project Report.
- 7.5 A candidate shall be allowed to submit the thesis / dissertation only after clearing all the prescribed subjects (both theory and practical) and then take viva voce examination of the project. The viva-voce examination may be conducted once in two months for all the candidates who submitted the project report during that period.
- 7.6 Three copies of the Thesis / Dissertation certified in the prescribed from by the supervisor & HOD shall be presented to the HOD. One copy is to be sent to the examiner.
- 7.7 The thesis / dissertation will be adjudicated by one examiner (for a batch of a maximum of 5 students) nominated by the Principal.
- 7.8 If the report of the examiner is favorable, viva-voce examination shall be conducted by a board consisting of the Supervisor, Head of the Department and the examiner who adjudicated the thesis / dissertation. The board shall jointly report candidate's work as per grade point.
- 7.9 The student must publish at least one journal paper (or) present one conference in the prescribed journals.

#### 8. Re-Registration for Improvement of Internal Evaluation Marks:

Following are the conditions to avail the benefit of improvement of internal evaluation marks.

- 8.1 The candidate should have completed the course work and obtained examinations results for I & II semesters.
- 8.2 He/she should have passed all the subjects for which the internal evaluation marks secured are more than 50%.
- 8.3 Out of the subjects the candidate has failed in the examination due to internal evaluation marks secured being less than 50%, the candidate shall be given one chance for each theory subject and for a maximum of three theory subjects for Improvement of Internal evaluation marks.
- 8.4 The candidate has to re-register for the chosen subjects and fulfill the academic requirements.

- 8.5 For each subject, the candidate has to pay a fee equivalent to one third of the semester tuition fee along with the requisition to the Principal.
- 8.6 In the event of availing the improvement of internal evaluation marks, the internal evaluation marks as well as the end semester examinations marks secured in the previous attempt(s) for the reregistered subjects stand cancelled.

#### 9. Supplementary Examinations:

At the end of each Semester there will be regular examinations for the current Semester. Those students who could not clear their courses in their previous attempt can appear for the examinations under supplementary category along with the regular students after registering themselves at the examination branch. Supplementary examinations for the all the other Semesters other than the current one will also be conducted at the same time.

**10. Letter Grade and Grade Point:** The letter grade and the grade points are awarded based percentage of marks secured by a candidate in individual course as detailed below:

A student obtaining Grade F shall be considered failed and will be required to reappear in the examination.

# 10.1. Semester Grade Point Average (SGPA) and Cumulative Grade Point

#### Average (CGPA):

#### (i) Semester Grade Point Average (SGPA)

The Semester Grade Point Average (SGPA) is the ratio of sum of the product of the number of credits with the grade points scored by a student in all the courses taken by

a student and the sum of the number of credits of all the courses undergone by a student, i.e.,

#### **SGPA** (S<sub>i</sub>) = $\Sigma$ (C<sub>i</sub> x G<sub>i</sub>) / $\Sigma$ C<sub>i</sub>

Where  $C_i$  is the number of credits of the i<sup>th</sup> course and  $G_i$  is the grade point scored by the student in the i<sup>th</sup> course.

#### (ii) Cumulative Grade Point Average (CGPA)

The Cumulative Grade Point Average (CGPA) will be computed in the same manner taking into account all the courses undergone by a student over all the semesters of a program, i.e.

# $\mathbf{CGPA} = \mathbf{\Sigma} \left( \mathbf{C}_{i} \mathbf{x} \mathbf{S}_{i} \right) / \mathbf{\Sigma} \mathbf{C}_{i}$

Where  $S_i$  is the SGPA of the i<sup>th</sup> semester and  $C_i$  is the total number of credits in that semester.

The SGPA and CGPA shall be rounded off to 2 decimal points and reported in the transcripts.

While computing the CGPA the subjects in which the student is awarded Zero grade points will also be included.

*Grade Point:* It is a numerical weight allotted to each letter grade on a 10-point scale.

*Letter Grade:* It is an index of the performance of students in a said course Grades are denoted by letters S, A, B, C, D, E and F.

#### 11. Award of Class:

The following Class is awarded to the student on successful completion of the M.Tech Degree. Programme depending upon the CGPA obtained;

#### **12.** With–Holding of Results:

If the candidate has not paid dues to the college or if any case of indiscipline is pending against him/her, the result of the candidate shall be withheld and he/she will not be allowed/ promoted into the next higher semester. The issue of degree is liable to be withheld in such cases.

#### **13. Transitory Regulations:**

Candidates who have discontinued or have been detained for want of attendance or who have failed after having undergone the course in earlier regulations and wish to continue the course are eligible for admission into the unfinished semester from the date of commencement of class work with the same or equivalent subjects as and when subjects are offered. However, the current academic regulations shall apply to them upon readmission.

#### 14. General:

- 14.1 The academic regulations should be read as a whole for purpose of any interpretation.
- 14.2 Malpractice rules nature and punishments are appended.
- 14.3 Where the words "he", "him", "his" occur in the regulations, they also include "she", "her", "hers", respectively.
- 14.4 In case of any doubt or ambiguity in the interpretation of the above rules, the decision of the Principal is final.
- 14.5 The Institute, with the approval of the Academic Council, may change or amend the academic regulations / structure / credits / syllabi at any time and the changes or amendments shall be made applicable to all the students on rolls with effect from the dates notified by the Institute.
