

- Thereafter, as per the decision taken by the committees for selection of centers and monitoring the progress, applications (online) have been called for from the institutions / organizations and 4. universities, duly notifying the same in the media, stipulating the last date for submission of application for expression of interest in order to operationalize the centers.
- In the reference 3rd read above, i.e., on 16-02-2016, during the Selection Committee meeting for Selection of Centers for the "Andhra Pradesh- Skill Development Project " in the form of hub-5. spoke model is explained Six clusters were defined. These are territorial region roughly consisting of two - three district. They have been defined based on the supply side information in terms of population, number of institutions, and capacity of those institutions. Alignment of the clusters has been made with the proposed industrial development while keeping district also as a geographical unit. Each cluster will be one Centre of Excellence (COE) and five Technical Skill Development Institutes (TSDI).

- Further, as decided by the committee, all the hosting institutions need to be inspected by a team of 6. experts. Accordingly, teams have been constituted comprising members from Technical Education Department, Central Institute of Tools and Design, Hyderabad (an autonomous organization under of Government of India) and Jawaharlal Nehru Technological Universities (JNTUs), Kakinada and Anantapur to inspections have been carried out and inspection reports have been submitted.
- Suitable criteria fixed for evaluation of the institutions and accordingly all the applications were graded 7. and Universities and Engineering Colleges were evaluated using one set of criteria and also Polytechnics restricted one set of criteria. The ranked list of universities/colleges/institutions by cluster/district has been prepared and they have been evaluated with reference to the prescribed criteria. Finally, the committee constituted for the purpose of evaluation has recommended and approved the Colleges/ Institutions/ Organizations as Centre of Excellence (COE)/Technical Skill Development Institutions (TSDIs).
- The Government after careful examination comprehensively, hereby orders that the institutions/ 8. organizations/Universities as shown in the Annexure are selected as Siemens Centers of Excellence (6)/Technical Skill Development Institutions (36) subject to the following conditions:-







As per the order, agreement has been executed between the APSSDC, SIEMENS and Design Tech Companies.
- In the G.O. 2nd read above, the Government has issued orders for formation of committees to monitor and to track the proposal of implementation of the SIEMENS Project and also Centre Selection Committee.
- As a sequel to the agreement entered with the SIEMENS and Design Tech Companies, meetings involving all the stakeholders have been held in the state sensitizing the institutions and presenting the significance and the requirements for starting SIEMENS Center of Excellence and Technical Skill Development Institutions.
- Thereafter, as per the decision taken by the committees for selection of centers and monitoring the progress, applications (online) have been called for from the institutions / organizations and 4. universities, duly notifying the same in the media, stipulating the last date for submission of application for expression of interest in order to operationalize the centers.
- In the reference 3rd read above, i.e., on 16-02-2016, during the Selection Committee meeting for Selection of Centers for the "Andhra Pradesh- Skill Development Project " in the form of hub-5. spoke model is explained Six clusters were defined. These are territorial region roughly consisting of two - three district. They have been defined based on the supply side information in terms of population, number of institutions, and capacity of those institutions. Alignment of the clusters has been made with the proposed industrial development while keeping district also as a geographical unit. Each cluster will be one Centre of Excellence (COE) and five Technical Skill Development Institutes (TSDI).

- Further, as decided by the committee, all the hosting institutions need to be inspected by a team of 6. experts. Accordingly, teams have been constituted comprising members from Technical Education Department, Central Institute of Tools and Design, Hyderabad (an autonomous organization under of Government of India) and Jawaharlal Nehru Technological Universities (JNTUs), Kakinada and Anantapur to inspections have been carried out and inspection reports have been submitted.

 - iv) Any contravention of the stipulated conditions as per MOU will disqualify the institution from hosting the COE or TSDI at any time and the Government has the right to replace the institution.



- In the reference 3rd read above, i.e., on 16-02-2016, during the Selection Committee meeting for Selection of Centers for the "Andhra Pradesh- Skill Development Project " in the form of hub-5. spoke model is explained Six clusters were defined. These are territorial region roughly consisting of two - three district. They have been defined based on the supply side information in terms of population, number of institutions, and capacity of those institutions. Alignment of the clusters has been made with the proposed industrial development while keeping district also as a geographical unit. Each cluster will be one Centre of Excellence (COE) and five Technical Skill Development Institutes (TSDI).

- Further, as decided by the committee, all the hosting institutions need to be inspected by a team of 6. experts.  - ii) If found unsuitable due to restrictions and place, ability to accommodate 50% of capacity to outsiders, residential facilities to outsiders, another suitable institution, satisfying the conditions will be substituted.
 - iii) Selected institutions need to execute an agreement with Andhra Pradesh State Skill Development Corporation (APSSDC)
 - iv) Any contravention of the stipulated conditions as per MOU will disqualify the institution from hosting the COE or TSDI at any time and the Government has the right to replace the institution.
 - v) Operational guidelines shall be issued separately.
